Sub: Submission of ASI 2015-16 return under the provision of the Collection of Statistics Act 2008 (7 of 2009) & Rules framed there under in 2011 regarding.

Sir,

The Annual Survey of Industries (ASI) is an important major source of Industrial Statistics in Karnataka/India. It provides information on structural growth and composition of organized manufacturing industries which includes Manufacturing processes, Repairs services, Gas and Water Supply, Cold Storage activities. As per the National Statistical Commission recommendations, District Domestic-Products (DDP) has to be estimated from Taluka Level to District Level. The analysis by CSO provides estimates upto State Level. In order to improve the situation to reduce the data gaps, the survey will be conducted for residual units by the State **Directorate of Economics and Statistics (DES)**, **Bengaluru** as per the directions of Director General, Ministry of Statistics and Programme Implementation, Central Statistics Office (Industrial Statistics Wing), Government of India. The survey has been conducted as per the statutory provisions of Collection of Statistics Act, 2008 (7 of 2009) and rules framed there under in 2011.

- 2. The District Statistical Officer has been appointed as the "Statistics Officer" by the Government of Karnataka under section 4 of the Collection of Statistics Act 2008 (7 of 2009) for conducting Annual Survey of Industries (ASI).
- 3. For the first time, the prescribed return of ASI 2015-16 should also be compiled through "e surakshate" web portal of Department of Factories,

Boilers, Industrial Safety Health, Bengaluru. The on-line data transmission helps to improve the quality of data and thus by avoiding the time involved in manual data collection, data entry etc., and enables quick preparation of time-bound reports of ASI. This software is developed in joint collaboration between Directorate of Economics and Statistics and Department of Factories, Boilers, Industrial Safety Health.

In case you have any difficulty in compilation of the return, you may seek the guidance either through instruction manual or approaching Directorate of Economics and Statistics, Head Office, Bengaluru / concerned District Statistical Officer.

4. The web portal for compilation of the ASI return has been designed to be user friendly. After compilation and successful validation, print out of the return may be taken and submitted through web portal along with a soft copy of balance sheet (in PDF format) and other accounts dully uploaded. In addition, hard copy (printout) of the return signed by competent authority (part-I) should be sent in duplicate (for the purpose, photocopies of the return may be taken) to the concerned **District Statistical Officer (DSO)** mentioned as "Confidential Return for ASI 2015-16" on the cover. You are also be requested to submit along with the return, two copies of the balance sheet, profit & loss account, Director's report and any other legal documents(s) in support of the information furnished by you in return. The information supplied by you will be kept confidential. You may retain a copy of the return for your record.
